A. TOBACCO RETAILER'S PERMIT

Tobacco Retailer Permits and related enforcement are provided by Yolo County in accordance with Ordinance 20-1 (Municipal Code Section 9.30) and related agreement adopted by City Council on January 15, 2020. Please refer to Yolo County's Master Fee Schedule for fees related to the Tobacco Retailer Permit program.

B. POLICE PERMIT RENEWAL PENALTY

A one-time penalty of 100% of annual fee shall be added to each Police permit renewed after expiration date

C. FINGERPRINT PROCESSING FEES

Fingerprinting: Live Scan \$25
Additional DOJ/FBI fees may be added

Fingerprinting: ink-rolled prints \$10

Additional Live Scan charges
 Fingerprints sent to the Department of Justice (one-time charge) \$32
 Fingerprints sent to the Federal Bureau of Investigation (one-time charge) \$24
